### PRIVACY NOTICE

#### Consent

1. This Notice serves to inform you that your personal data is being processed by Novus or on Novus's behalf when Novus collects your personal data from any of the sources referred to in paragraph 4 below. You hereby give your consent to the processing of your personal data by Novus.

### **Description of personal data**

2. Novus may collect a variety of your personal data including but not limited to your name, date of birth, company name, photographs, Identification Card number, e-mail address, address, contact number, credit card details, bank account details, other personal data you submitted to Novus through any software or system developed and/or operated by Novus, including without limitation Novus's website at https://middletown.novusescaperoom.com (the "System") and all other personal data Novus again collects from you on any subsequent occasion.

### **Purpose**

- 3. Your personal data is being or is to be collected and further processed for any of the following purposes ("**Purposes**"):

# Source of personal data

4. # Access to, correction of and limiting the processing of personal data

6. Obligatory personal data will be indicated in the relevant forms.

### Transfer of personal data to places outside the United States

11. Novus may transfer your personal data to a place the United States and you hereby give your consent to the transfer.

# Accuracy of your personal data

12. You are responsible for ensuring that the information you provide to Novus is accurate, complete, not misleading and kept up to date.
